The following is the local educational agency's (LEA's) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. The plan will explain how the LEA will use the funds it receives through the Expanded Learning Opportunities (ELO) Grant to implement a learning recovery program for at least the students included in one or more of the following groups: low-income students, English learners, foster youth, homeless students, students with disabilities, students at risk of abuse, neglect, or exploitation, disengaged students, and students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

### **Plan Descriptions**

Parents, teachers, school staff, and community representatives were consulted in a series of outreach sessions at ELAC meetings, PTA meetings, staff meetings and community forums, all held virtually and, aside from the staff meetings, all involving English-Spanish translation. Discussions focused on the needs of Shoreline's students in the immediate aftermath of the global pandemic as well as their needs in the future, based on performance data, narrative data, and anecdotal information. The District Leadership team analyzed the data and considered all the seven allowable strategies, before selecting those listed below.

A description of how students will be identified and the needs of students will be assessed.

All students will be invited to participate in the Summer Extended Learning programs. In addition, the District will identify students in need of direct academic, social-emotional, or other support by reviewing academic performance data, report card grades, discipline referrals, attendance data, and referrals to district counseling services. District staff will also be encouraged to make referrals, based on their experience with the students. All students identified for services will be assessed within the regular District academic assessment system, with their results flagged for greater scrutiny. Similarly, the discipline records of identified students will be flagged and reviewed regularly. Counseling staff will confer with administration to report on the progress of targeted students.

Parents of identified students will receive personalized outreach and encouragement to allow their children to take advantage of the program offerings. All students attending summer learning opportunities (including credit recovery) will be provided home-to-school transportation at no cost. All students attending summer learning opportunities will receive school meals (including breakfast, lunch, and an afternoon snack) at no cost.

Parents will be informed of their children's eligibility for these programs in the following ways:

- Broad outreach through the district digital communication platform (Parent Square) in both Spanish and English
- Broad outreach through parent organizations (PTA, ELAC, etc.) in both Spanish and English
- Targeted outreach via phone calls and emails from the District Family Advocates, teachers, and other school staff in the parents' home languages

A description of the LEA's plan to provide supplemental instruction and support.

#### the District will:

- 1. Extend learning time by providing free summer learning opportunities through local contracts with the YMCA, Camp EdMo, the Marin County Free Library, and 10,000 Degrees, at two strategically located school sites for all students, K-8. The District will also provide credit recovery opportunities for high school students during the summer through a supervised online platform. (Area 1)
- 2. Provide Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff during the school year to accelerate progress and to close learning gaps. (Area 2)
- 3. Integrate student supports to address other barriers to learning, by providing counseling, home-to-school transportation, access to school meal programs, and programs to address student trauma and social-emotional learning, or referrals for support for family or student needs. (Area 3)
- 4. Provide computer-based credit recovery on-site with staff support for students (Area 5)
- 5, Train school staff on trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs. (Area 7)

Additionally, the West Marin Fund has indicated an interest in supporting these efforts with a significant contribution to support students' participation and to the District's ongoing efforts to offer extended learning opportunities.

Given this donation, it is anticipated that the 2021 Summer Extended Learning Opportunity Program will cost the District approximately \$310,000 of the funds listed above, leaving approximately \$450,000 to be expended during the 2021-22 school year and the summer of 2022, prior to the deadline to expend all funds.

### **Expanded Learning Opportunities Grant Plan Instructions: Introduction**

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code* (*EC*) Section 43521(b). The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before June 1, 2021, and must be submitted to the county office of education, the California Department of Education, or the chartering authority within five days of adoption, as applicable. ### **Instructions: Plan Requirements**

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

#### For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

#### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

• An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
