How we got here

March 13, 2020

Public Health Order to Suspend Classroom Instruction for two weeks

Subsequent Public Health Orders

Classroom Instruction Suspension extended through April 3, 2020, then April 30, 2020, then through May 30th, then through the end of the school year.

“Based on what we know now...”

Distance Learning

Devices sent home with some students.

Paper/pencil activities with others.

Staff surveyed all families regarding broadband access.

Devices sent out to all students.

Hot spots from the Marin Free Library distributed.

Regular virtual class sessions, phone calls, one-on-one video.

Parent Survey Conclusions

Eng Survey: 51 Responses / Span Survey: 16 Responses

Feedback:

- Understood expectations
- Communication was clear
- Virtual supported SEL
- More direct instruction
- Home instruction a challenge

Takeaways:

- Kids back on campus
- % of families not sending kids back until vaccine
- Busing for at least half of our students
- 70-80% essential workers

Student Survey Conclusions

100 Students (Grades 4-12)

What worked from distance learning:

- Zoom/Google Classroom/Seesaw
- Teachers were available to help and answer questions
- Frequent communication and consistent schedule

What was challenging:

- Motivation and Distractions at Home
- It was hard to understand the new concept

Did you experience stress during the time of distance learning?

63 Yes 25 No

Overall, students want to return to school!

Staff Survey Conclusions

55 responses (classified and certificated)

- Three strategies or resources that have worked for you:
 - Platforms/ Instructional Strategies/ Advice
 - Communication
 - Collaboration
- The majority of respondents:
 - want to return to campus,
 - are not at high risk for Covid-19,
 - have good internet access
- Ideal on campus situation:
 - Pre-Covid, Normal
 - CDC Guidelines
 - Cohorts
 - Limited time on campus (minority)
- Concerns:
 - Resources or lack thereof (i.e. EPE, time, training, internet access for students)
 - Students mental health
 - Health and safety protocols
 - Transportation
 - Childcare

Health & Safety Conclusions

What will be available?

- Sanitation needs (hand sanitizers, etc.)

- Cleaning supplies (cleaning, vs. sanitizing, vs. disinfecting)

- Thermometers

- Supplies (face coverings, gloves, etc.)

What safety practices can we put in place now?

- Health screenings

- Sanitizing stations

- Testing for staff

Fall 2020 Goals

Independent study for the students who can't come

Transportation plan pending County guidance

Plan to assess for learning gaps from spring 2020

Social emotional support

Parent education

Ability to pivot back to DL if needed
